to prepare an appropriately thorough Busi-
ness Rescue Plan, the business rescue prac-
titioners obtained a further extension with
the requisite support of the creditors, as
contemplated in section 150(5)(b) of the
Companies Act, and the Business Rescue
Plan will now be published on 30 August
2019.
